- Copy of a utility bill showing service address (Epcor, Direct Energy, etc..)
- If property owner, a copy of Property Tax Assessment

ALL documents must be included and confirm residential address within Elite Draw Zone boundary. Application will not be reviewed and will be deemed incomplete if the above is not provided.

A player's residence shall be determined in reference to the residence of his/her parent(s) as defined in Hockey Canada Regulation C3.

In the case of a separation, or when legal custody has been granted to a third person, the following document must also be provided:

- Executed copy of any relevant separation agreement, custody order or divorce decree
- Other (any relevant additional supporting documentation)
